*) Please note the following excerpt from the General Terms and Conditions of docu tools GmbH before placing your binding order:

6. Duration and termination

6.1 When ordering a product on a monthly basis, the customer can terminate the user relationship with docu tools GmbH at the end of each month, subject to a notice period until his next charge period (Attention not calendar month), by sending an E-Mail to sales@docu-tools.com in which the customer declares their intention to terminate use.
